Additional Information

The cut-off date to order footer installation is **April 1** for installation by Memorial Day and **October 1** for installation by Thanksgiving Day.

A 36-hour notice is required for opening and closing of graves. Monday services require notification by 12:00 pm on the prior Friday.

After graveside services are concluded, families must depart within one hour.

There is a 32" minimum for a single gravestone in Sections I-J-K.

Funeral home directors will be held responsible for costs incurred with a late arrival.

All fees for services must be paid in full prior to the purchaser receiving services.

All cemetery rules and regulations must be agreed to and followed prior to receiving services.
